

In order to do business with the ProMinent group we do require our suppliers to comply with the criterias outlined on the following pages.





2020 to Q2 2021: You will need to contact Procurement directly and to complete a supplier self evaluation form provided by ProMinent Procurement

From Q2 2021 onwards:In order to attract ProMinent's interest in your company you must register and apply only thru our supplier portal. This will require to complete standard online forms as well as potential individualized forms based on the products you offer. Suppliers must agree to collaborate thru Ariba in strategic as well as operational procedures. Suppliers not complying with this will be excluded from any business engagement.

ProMinent will perform various Risk analysis steps in order to understand the health of your company prior to engaging with your business.

In order to do business with ProMinent your company will have to enter into contract negotiations. All negotiations will be led by the ProMinent Procurement organisation.
